Craft called the meeting to order at 6:30 PM and stated this was an open meeting of the Hadar Village Board. The Open Meetings Act poster was displayed and accessible to the public.

Motion by Wehrer, seconded by Sudbeck, to approve the April minutes as written. All in favor. Motion carried.

Chairman Craft read the official Treasurer's Report for April. Motion by Sudbeck, seconded by Wehrer, to approve the April Treasurer's Report. All in favor. Motion carried.

### Department Updates:

Wehrer – Presented a check paying for the Hall rental for the Bargain Buy-Way. A check was also presented from Pierce County in the amount of \$350.00 for the Horseshoe Tournament grant.

**Building Permits:** A building permit was brought before the board by Adam Foreman and tabled until the June 2026 meeting.

**Todd Borgmeyer – Lot Split -** Motion by Sudbeck, seconded by Wehrer, to approve the lot split for the 2nd Addition to Hadar, NE. All in favor. Motion carried.

**Resolution:** Motion by Wehrer, seconded by Sudbeck, to approve the Pierce County Local Emergency Operations Plan Resolution. All in favor, motion carried.

**Other Business:** MFO funds have not yet arrived for distribution.

Gary Schuett discussed work completed at the park, including cleaning out the shed, adding new boards to the back of the steps, adding gravel under the bleachers, and painting the new boards blue.

Wehrer presented a check to Gary Schuett paying for the rental of the Fire Hall for the Bargain Buy-Way.
